

HMS 115 Home Visitor II ECH Prerequisite: HMS 100 and HMS 112 3 credit hours (Lecture)

Course Description:

This course will cover the final steps necessary for requesting national Home Visitor Child Development Associate (CDA) credentialing. The course will include working cooperatively with community agencies providing family services, such as health care, mental health, nutrition, and social services. During the course, students will be observed conducting home visits and will complete parent opinion questionnaires, reflect on their professional development, and complete the direct assessment application for the Home Visitor CDA credential.

Course Competencies:

Upon completion of the course, the student should be able to:

- 1. Achieve all competency goals when conducting home visits.
- 2. Exhibit appropriate Home Visitor behaviors.
- 3. Write an action plan based on family needs
- 4. Identify areas of personal strength and future professional growth as a Home Visitor.
- 5. Administer parent questionnaires and write an action plan to address parent issues.
- 6. Complete and submit the application for the Home Visitor CDA credential.
- 7. Identify community resources for families.
