Course Description:

This course is designed to provide an individual exercise and fitness evaluation and program. The course will focus on how to develop and maintain a fitness lifestyle.

Course Competencies:

Upon completion of the course, the student should be able to:

1. Define physical fitness and explain how it relates to health and wellness.
2. Integrate physical activity into a physical fitness program.
3. Explain the relationship of nutrition to health and wellness.
4. Describe how to develop and maintain basic elements of physical fitness, such as cardiovascular endurance, strength, flexibility, and body composition.
5. Explain the causes of stress and describe ways to manage stress.
6. Evaluate the status of his or her own physical fitness.
7. Plan a personal fitness program.
8. Identify types of physical activities that can contribute to lifetime fitness.
9. Identify resources that can contribute to a fitness program.
